UPON MY ARRIVAL AT PINE ST AND FELTON DR , I WAS FLAGGED DOWN BY THE LISTED WITNESSES. THEY POINTED ME TOWARDS THE ADDRESS OF 353 PINE ST STATING A WOMAN HAD JUST BEEN BEATEN . I PROCEEDED TOWARDS THE VICTIM WHOM WAS BLEEDING FROM THE HEAD. THE VICTIM STATED "HE" HAD BEEN PICKED UP BY THE LISTED SUSPECT FROM 708 SPRING ST AND TAKEN TO AN ADDRESS OFF OLD NATIONAL HIGHWAY, TO A HOUSE WHERE THEY HAD SEX FOR MONEY. THE VICTIM STATED THE SUSPECT WAS BRINGING "HIM" BACK DOWNTOWN WHEN HE PULLED OVER IN FRONT OF 353 PINE ST. THE VICTIM ASKED "WHY ARE WE STOPPING HERE", AND THATS WHEN THE SUSPECT STATED "IM TIRED OF YALL BITCHES TAKING MY MONEY" AND DEMANDED THE VICTIM GIVE BACK HIS MONEY. THE VICTIM STATED "HE" HESITATED FOR A FEW SECONDS AND THATS WHEN THE SUSPECT PULLED A LARGE BLACK PISTOL AND POINTED IT AT HIM. THE VICTIM STATED "HE" GRABBED THE GUN AND IT DISCHARGED ,GRAZING HIS LEFT THIGH. THE VICTIM STATED "HE" THEN TOOK THE GUN AND STRUCK THE SUSPECT ABOUT THE HEAD AND FACE CAUSING HIM TO BLEED. THE VICTIM STATED"HE" OPENED THE PASSENGER DOOR AS THE STRUGGLE CONTINUED AND THATS WHEN THE SUSPECT TOOK THE GUN BACK AND STARTED BEATING THE VICTIM ABOUT THE FACE AND HEAD. THE VICTIM STATED THE AMMO CLIP FELL FROM THE GUN AND HE THREW THE CLIP DOWN THE HILL AWAY FROM THE FIGHT. THE SUSPECT CONTINUED STRIKING THE VICTIM WITH THE GUN AND WHEN HE REALIZED THE GUN WOULD NOT FIRE HE .STARTED BITING THE VICTIM ON THE LEFT EAR AS THEY STRUGGLED ON THE GRASS. THE VICTIM STATED HIS LEFT EAR WAS PARTIALLY SEVERED IN THE GRASS AND THAT HE HEARD THE SUSPECT SPITTING IT AWAY FROM HIS MOUTH. (THE PARTIAL EAR COULD NOT BE LOCATED IN THE GRASS AFTER AN EXTENSIVE SEARCH BY OFFICERS AND THE CSI UNIT). THE SUSPECT THEN GOT BACK INTO THE VEHICLE AND SPED AWAY EAST ON PINE ST. A DESCRIPTION OF THE SUSPECT AND VEHICLE WERE GIVEN OUT OVER THE RADIO. THE VICTIM WAS ABLE TO GET A PARTIAL TAG ON THE VEHICLE, STATING "HE" BELIEVES THE SUSPECT AND THE VEHICLE ARE FROM LOUISIANA. THE SUSPECT LOST HIS EYE GLASSES, WATCH, CIGARETTE LIGHTER AND MAGAZINE CLIP FROM A .45 CALIBER PISTOL DURING THE STRUGGLE. THOSE ITEMS WERE RECOVERED AND TURNED INTO THE PROPERTY MANAGEMENT SECTION. A BLOOD SWAB WAS TAKEN BY CSI TECH OTEY # 7335 FROM THE MAGAZINE AND SENT TO THE STATE CRIME LAB FOR PROCESSING. INVESTIGATOR BACON,#4380 WENT TO GRADY HOSPITAL TO DO A FOLLOW UP WITH THE VICTIM. INVESTIGATOR A.FOSTER RESPONDED TO THE SCENE ALSO, UNIT#3596 SGT. HALL WAS ALSO NOTIFIED OF THE INCIDENT.
